### **Presentation**

Presentation by Jeff Sullivan of Canton Walk, Bike Hike Committee regarding Mary E Wentworth Recreation Facility (Bolivar Pond Area)

### **Discuss/Vote On-site septic repairs:**

#### **5 Oxbow Road.**

Applicant seeks local upgrade approval from section 310CMR 15.221 of the State Sanitary Code which allows a maximum 36-inches of cover over all system components. Vote to allow to 48-inches of cover over the tank and pump chamber - providing no increase in flow.

#### **7 Wayside Lane**

Applicant seeks local upgrade approval in accordance with Massachusetts Department of Environmental Protection "Title 5 Alternative to percolation Testing Guidance for System Upgrades" to allow loading rate determination based on sieve analysis in lieu of required on-site percolation test. Vote to allow the determination of loading rate based on sieve analysis of in-situ soil sample - providing no increase in flow

Applicant seeks local update approval from section 310CMR 15.405(h) of the State Sanitary Code to allow a 3-foot separation between the bottom of the soil absorption system and groundwater in lieu of the 4-foot separation required. Vote to allow a 3-foot separation between the bottom of the soil absorption system and groundwater -providing no increase in flow.

#### **408 York Street**

Board to act on Health Director's recommendation that Enforcement Order be issued to property owner of 408 York Street. Enforcement Order would order replacement of on-site septic system that was installed without Disposal System Construction Permit.
